## A. POLICY:

Participation of Society Members in Student Clubs

## B. PURPOSE/COMMITMENT:

As a non-profit Society, Columbia College values Society members who take part in extracurricular College activities such as a College approved club. Clubs play an important and inspirational role in the Students' College experience.

The purpose of the policy is to define the time taken when a Society member sponsors or participates in a Club.

## C: SCOPE

This policy applies to Columbia College Society members.

Clubs are run by Club Sponsors. As a leader, the Club Sponsor has an inspirational role while being responsible for creating a Club where students can have an enriching experience in a respectful and trustworthy environment. Society members can apply to sponsor a Club, and upon approval by the Student Services Manager, Club Sponsors are remunerated an hourly amount up to a maximum number of hours each semester. Society members may also participate in Clubs if space permits.
