HOMESTAY STUDENT AGREEMENT FORM

I, _____, have received and read the Columbia College Homestay Program Student Handbook.

I agree as a condition of attending Columbia College and participating in the Homestay Program I will:

- a. Comply with all terms of the Homestay Program Student Handbook.
- b. Respect my host family's home and their house rules.
- c. Respect the privacy of other family members and students living in the home.
- d. Attend school regularly
- e. Reimburse the host family for any damages I cause while living in homestay.
- f. Comply with the laws of Canada and British Columbia.
- g. Comply with the Homestay Internet Appropriate Use and Privately-Owned Electronic Devices Appropriate Use policies.
- h. Not use drugs, alcohol or smoke if under the age of 19.
- i. Not change Homestays without the consent of the Homestay Coordinator.
- j. Provide 30 days' notice to move or leave homestay. I understand this may result in being penalized two weeks' homestay fee.
- k. Move out of homestay when I am no longer studying at Columbia College.
- l. Not be in possession of any; pellet, water or gun replicas.
- m. Not have relations with other homestay students living in my homestay.
- n. Not have any over night guests without the permission of my host family.
- o. Follow the Columbia College Sleepover Policy.
- p. Follow the Columbia College Curfew Policy, IF I require custodianship:

CUSTODIANSHIP CURFEW

Weekend curfew time (Friday and Saturday night):

- 11:00 pm for 15 and 16-year old
- 12:00 am for 17 and 18-year old

Weekday curfew time (Sunday to Thursday):

- 9:00 pm for 15 and 16-year old
- 10:00 pm for 17 and 18-year old

SLEEPOVER POLICY

- Custodial students wishing to spend the night outside of homestay (the other party is NOT staying in a Columbia College homestay) must first notify the Homestay Department within 24 hours prior. The student will provide full details on where they will be staying.
- The Homestay Department will contact the natural parents provide details, and request written permission. The natural parents must provide permission through the Homestay Department ONLY and not directly to the host family.
- The Homestay Department will contact the host family based on the natural parent's decision.
- The College nor Host Family will be not responsible for the safety or well-being of the homestay student while staying outside of the homestay.

I _____, understand if I fail to comply with the rules or guidelines disciplinary action will be taken and could result in notifying my natural parents (if a custodianship student) or be asked to leave the Homestay Program altogether.

The College reserves the right to ask a student to leave the Homestay Program at any time if a student's behavior in the host family's home is inappropriate or unacceptable.
